

## REGULATIONS OF THE V SUMMER ORCHESTRA WORKSHOP SOW 2025 (AUGUST 11-16, 2025)

The organizer of the V Summer Orchestra Workshop SOW 2025 (Summer Orchestra Workshop) is the "Pro Musica Center for Art and Culture" Foundation in cooperation with the Center for Culture and Recreation in Supraśl. The workshop will take place in Supraśl from August 11 to August 16, 2025.

Participants register for the workshop using the application form available on the website [www.promusica.org.pl](http://www.promusica.org.pl). Registration will be open until June 10, 2025. After the repertoire is published, the selected participant will receive sheet music materials electronically. A copy of the application form will be sent by email as confirmation of registration and acceptance into the workshop.

The workshop costs include 120 euro for participation and (optionally, for those interested) 70 euro for organized lunches.

Participants are requested to pay the registration fee of 130 euro by June 10 to the account of the "Pro Musica Center for Art and Culture" Foundation. If the participant wishes to purchase lunches, an additional 70 PLN should be paid.

The organizer reserves the right to cancel the workshop until June 30. In case of cancellation, the registration fee will be refunded.

The workshop is intended for individuals aged 11 and above.

During rehearsals and concerts, participants must adhere to the etiquette expected for such events.

Participants are required to be punctual for sectional and orchestral rehearsals according to the schedule published on [www.promusica.org.pl](http://www.promusica.org.pl) and to actively participate in planned concerts.

Filming and photographing during the workshop are only allowed with the consent of the instructor. The organizer prohibits participants from recording (audio and video) workshop activities or reproducing them without prior consent from the Workshop Organizer and other group members participating in the workshop. Audiovisual recording of activities and concerts without the organizer's consent is strictly prohibited.

Classes will be conducted according to the official schedule, which will be published by the organizer after the registration period ends. This schedule will be available on the organizer's website [www.promusica.org.pl](http://www.promusica.org.pl) and sent to participants via email.

The organizer reserves the right to conduct promotional activities for the workshop in institutions and media, including but not limited to press, the Internet, radio, and television. By participating in the workshop, the participant grants the organizer permission to document the workshop's progress, including images of participants, their artistic performances during concerts held as part of the workshop, and any statements made by participants regarding the workshop when requested by the organizer.

Upon completion of the workshop, participants will receive certificates confirming their participation in the V Summer Orchestra Workshop SOW 2025.
